2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

The Institution makes sure that every student is informed about internal and external evaluation procedures. Internal evaluation that is conducted on a regular basis is the core of the entire teaching-learning process.

Evaluation occurs on two levels:

1. Internal
2. External

The Institute adheres to the standards established by the PCI and the affiliated university for the evaluation procedure.

Salient features:

Marks distribution:


The internal and external marks for M. Pharm (PG) and B. Pharm (UG) is 25 and 75 marks respectively. However, for the Pharm D course it is 30 and 70 respectively. For B. Pharm. (UG) two internal sessional exams are conducted in each semester and an average of marks obtained in these are considered as internal sessional exam marks. While, for Pharm. D. three internal sessional exams are conducted and an average is calculated by taking higher marks in any of two sessional exams. Transparency is maintained by showing assessed answer books to the all appeared students. Any discrepancy in allotted marks is resolved by the concerned subject teacher upon a claim from student(s). By the end of semester, the average sessional marks are displayed on student notice board. Question papers and answer scripts, selected records and practical manuals are well preserved.

After the declaration of University semester exam results, any student who is not satisfied with the marks obtained in University semester exam upon evaluation can apply for reevaluation. This process of reevaluation of answer books is always time-bound as per the circulars from the University from time to time.

At the Institute level:

To address the grievance of the students regarding internal exams, a three-stage grievance redressal system is offered by Institute.

First Stage [At teacher level]- The student may clarify any questions or grievances by receiving revised answer scripts from the teacher.


Second Stage [At Convener (Examination Cell) level]- If a student is unsatisfied at stage one, he or she may contact the Convener of the Examination Cell, who will then convey the request to the relevant department's head of department, who is expected to thoroughly review the situation and make appropriate revisions if necessary.

Third Stage [At the Principal level]- If the student disagrees with the decision even at the Convener Examination Cell or HOD level, student may appeal in writing to the principal, who will then choose a professor or Associate Professor other than the subject teacher to investigate the issue. In order to justify the student fairly, the principal nominated teacher will closely analyze the complaint. The decision kept final, and the consequence is explained to the student with justification.

At the University level:

The student has the right to request revaluation or re-counting in theory subjects by paying the requisite amount to the University through the Principal. All of these applications are accepted by the university, and the answer books are revised by subject experts. But if there is no progress, the previously evaluated marks will stand as it is.
