## Purpose

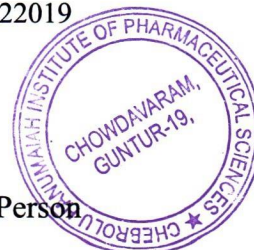

## **MUTUAL NON-DISCLOSURE AGREEMENT**

This Agreement is entered into by and between "Indira College of Pharmacy", with its principal place of business at "Vishnupuri, Nanded, Maharashtra, 431606, India" (the "Company") and DFE Pharma GmbH & Co. KG, a German limited partnership with its principal place of business at Klever Straße 187, 47574 Goch ("DFE").

The Company and DFE intend to evaluate their possible interest to enter into any form of commercial relationship between them relating to excipients used in 3D printing and 3D printing applications and equipment. In the course of such discussions and negotiations, it is anticipated that each party may disclose or deliver to the other certain trade secrets or other confidential or proprietary information for the purpose of enabling the other to evaluate the feasibility and desirability of establishing such a commercial relationship, or either party may otherwise gain access to trade secrets or other confidential or proprietary information of the other. The Company and DFE have entered into this Agreement in order to assure the continued confidentiality of such trade secrets or other information in accordance with the terms of this Agreement.

### **NOW, THEREFORE, the parties agree as follows:**

1. As used in this Agreement, the term "Proprietary Information" shall mean all confidential or proprietary information, and proprietary materials, of one party (the "Disclosing Party"), including trade secrets, know-how, formulations, techniques, equipment, data reports, computer software, and information regarding sources of purchase and supply, patent positioning, business plans, and the existence, scope and activities of any research, development, manufacturing, marketing or other projects of the Disclosing Party (including negative developments), to which the obligations of the other party (the "Recipient") under this Agreement shall apply in accordance with paragraph 2.
2. The obligations of the Recipient under this Agreement shall apply to all Proprietary Information of the Disclosing Party which has been or may hereafter be disclosed, directly or indirectly, to the Recipient by the Disclosing Party, either orally or in writing, or delivered to the Recipient.
3. The Recipient and its personnel shall use Proprietary Information only to the extent necessary to determine the feasibility and desirability of establishing a commercial relationship with the Disclosing Party, and shall not use or exploit Proprietary Information for its or their own benefit or of another party without the prior written consent of the Disclosing Party. The Recipient shall disclose or deliver Proprietary Information only to persons within its organization who have a need to know the same in the

course of performance of their duties and who are bound by a written agreement to protect the confidentiality thereof.

4. The Recipient shall not directly or indirectly disclose, communicate or in any way divulge to any other person or entity any Proprietary Information (or, if the Recipient is not an individual, permit or suffer its personnel to do so). The Recipient shall use the same degree of care, but no less than a reasonable degree of care, to prevent the disclosure of Proprietary Information to others as it uses to prevent the disclosure of its own confidential or proprietary information.
5. Notwithstanding this Agreement, the Recipient may use or disclose Proprietary Information to the extent the Recipient can demonstrate, by clear and convincing evidence, that such Proprietary Information:
  - (a) at the time of disclosure or acquisition is generally available to the public, or after the time of disclosure or acquisition becomes generally available to the public through no wrongful act of the Recipient;
  - (b) is rightfully in the Recipient's possession prior to the time of disclosure or acquisition, and the Recipient's intended use or disclosure would not violate any restriction on use or disclosure binding on the Recipient;
  - (c) is rightfully made available to the Recipient by others, and the Recipient's intended use or disclosure would not violate any restriction on use or disclosure binding on the Recipient, or
  - (d) is disclosed by the Recipient in order to comply with the requirements of applicable law or governmental regulation, provided that the Recipient gives the Disclosing Party prior written notice of such disclosure and takes reasonable actions to avoid such disclosure or minimize its extent.
6. The Recipient agrees that the Disclosing Party is and shall remain the exclusive owner of all Proprietary Information and all patent, copyright, trade secret, trademark and other intellectual property rights therein. No license or conveyance of any such rights to the Recipient is granted or implied under this Agreement.
7. The Disclosing Party represents and warrants that by making any disclosure under this Agreement it does not violate any legal obligation by which it is bound.
8. This Agreement will end 10 years from the date of execution hereof by both Parties, but without affecting the liability of either party hereto for breach of the Agreement before then.
9. Upon termination of this Agreement or at the request of the Disclosing Party, the Recipient shall promptly deliver to the Disclosing Party all drawings, data, memoranda and other tangible manifestations of, and all materials constituting, Proprietary Information (and all copies and reproductions thereof).



10. Nothing herein shall create or be construed to create an obligation of either party hereto to enter into any further agreement. This Agreement may not be modified except by mutual written consent of both parties, and supersedes all prior agreements, written or oral, between the parties relating to its subject matter. This Agreement shall be governed by and construed under the laws of Germany.
11. The Recipient agrees that its obligations hereunder are necessary and reasonable to protect the Disclosing Party, and expressly agrees that monetary damages would be inadequate to compensate the Disclosing Party for any breach of any covenant or agreement set forth herein. The Recipient agrees and acknowledges that any such violation or threatened violation would cause irreparable injury to the Disclosing Party and that, in addition to any other remedies that may be available, in law, in equity or otherwise, the Disclosing Party shall be entitled to obtain injunctive relief against any threatened breach of this Agreement or the continuation of any such breach, without the necessity of proving actual damages.
